### **SATURDAY, JUNE 9 - 10:00 am**

#### **★ Reining ★**

Wendy Woldt will spend the day helping interested riders with reining technique. Sessions will be broken down into beginner, intermediate & advanced riders. Ten (10) riders per 90 minute session. (Beginner: Little experience & skill; Intermediate: Must be able to lope a circle, stop, roll back, pick up leads and do canter departures; Advanced: In addition to intermediate skills, must be able to perform flying lead changes and spin.)

#### **★ Trail ★**

All possible obstacles will be set out. Riders will be able to work the obstacles and help will be available to the rider/horse upon request.

#### **★ Stock Horse Pleasure ★**

Individuals can practice a pleasure pattern from 9 to 10am and be video taped from 10am to noon. Later in the day the rider will be able to watch their pattern and be critiqued if requested.

#### **★ Roping Basics ★**

Brandon Schopf will be available to help individuals with their ranch roping/breakaway roping techniques. Roping dummies will be used.

#### **★ Cattle Working Basics ★**

Riders will ride their horses through a group of cattle to allow your horse to gain confidence around cows.

#### **★ Saturday Evening ★**

• Dinner will be available on the grounds for purchase.

• We will be viewing all video footage taken during the day. • Campfire and social activities available.

#### **★ Trail ★**

The trail pattern will be available for participants to practice.
